 - i. Robin Wong, Women's Firststep
 - 1. Women's kitchen is now open and being used. The ladies love the new space and its going very well.

2. Opening event will be March 6. It will be a continental breakfast held in the new kitchen. There will be tours going on as well.
 3. Numbers are beginning to come up after the slump of the holidays.
 4. Now working with peaceful family solutions on a new program involving the children of the clients. The purpose is to help the children gain skills and knowledge to deal with having a parent struggling with addiction.
- ii. Steve Gates, Men's Firststep
 1. Numbers are also going up since the holidays. The daily average has stayed at about 63 men in January.
 2. Worksites and client numbers will improve as the warmer months come along.

 3. Completed CPR and safety certifications this past week for 20 of our employees from all OKCMA programs. The first of the year is used to focus on safety and training for all employees throughout the agency.
